



Rules & Regulations for the International Photo Contest "Beauty of Rotorcrafts 2024"

Contest period: 21.02 -1.05.2024.

The Helicopter Industry Association organizes **the 17th International Photo Contest "Beauty of Rotorcrafts"** for the best helicopter-themed photos.

The objective of the contest is to promote interest in helicopter photography, showcase the best work of photographers working within the helicopter industry and rotorcraft fans also promote helicopters in modern society, as well as promote helicopter sports in Russia.

The contest is open and proceeds in one round.

Photo Contest nominated categories:

- Helicopter-Sportsman
- Helicopter-Toiler
- Helicopter-Soldier
- Helicopter & Nature
- KLIMOV ENGINE IS A HEART

A standalone prize in the nomination will be presented by JSC "UEC-Klimov": "KLIMOV ENGINE IS A HEART". It will be awarded to the author of the best photograph of helicopter engines developed by JSC "UEC-Klimov" (TV3-117, VK-2500, TV7-117V).

Contest results are published on the official website of the Helicopter Industry Association <https://helicopter.su/fotokonkurs-krasota-vintokrylyh-mashin/>, as well as on the official website of the XVI International Helicopter Industry Exhibition HELIRUSSIA2024 - www.helirusia.ru.

The Award Ceremony is held on June 12th, 2024 at 1:00 p.m. on the Main Stage of the exhibition hall of Pavilion 1 at Crocus Expo where the HELIRUSSIA 2024 International Helicopter Industry Show takes place.

The winners of the contest will receive special prizes from the Helicopter Industry Association, sponsors and partners of the contest.

Participation in the contest is free, i.e. no fee is envisaged.

1. Terms of participation:

1.1 Photo illustrations corresponding to the topics of the nominated categories are admitted to the contest.

1.2 Maximum number of the photos from one participant is 2 (two) in each category.

1.3. Photo illustrations can be competed in only one category.

1.4 All rights to the photo illustrations selected for the short list and final for the exhibition are being the property of the Organizer. The Organizers reserve the right to use the photos submitted for the contest in advertising the event, for information and other non-commercial purposes, for press and other written publications, on television, on the Internet, etc.

1.5 Contest photos shall not be reviewed and shall not be returned.

2. Contest participants:

Russian and foreign authors - professional and amateur photographers - are invited to participate in the Photo Contest.

3. Categories of participants:

- novice photographers
- Experienced young photographers

4 Contest Photo Contest requirements:

4.1 Digital photographs are accepted. Contest photos should be sent to bulat@rvs-holding.ru or photo@helicopter.su

4.2 Contest entries must meet the following requirements:

- image format: jpg (jpeg)
- resolution: 300 dpi
- image size: 3 to 5 MB

5. Procedure for submitting photo illustrations to the Contest:

Photo illustrations are accepted with a cover letter containing the following information:

- name of the Photo illustration
- nominated category
- family name, first name of the author
- author's year of birth
- home address including postal code
- contact telephone number
- email address

6. Evaluation criteria:

- relevance to the objectives of the contest
- relevance to the theme of the category
- appropriateness to technical requirements
- quality of the Photo illustration
- originality, absence of plagiarism
- creativity
- artistic expression

7. Photo entries that are not admitted to the contest.

- do not meet the contest requirements
- are presented anonymously
- photos with advertising information, logos, captions, frames or other prints.

8. The Organizers are not responsible for:

8.1. Technical faults in email, communication networks and data transmission when sending/receiving photo submissions.

8.2. Technical failures, technical malfunctions on the website, in case they are not the fault of the Organizers.

8.3 Duplication and distribution of the photos from the Contest website by the third parties.

8.4 Failure to receive the information required to receive the prizes and diplomas due to the fault of the Contest participants themselves or the communication service providers, or for other reasons beyond the control of the Organizers.

8.5 Contestants failing to fulfil their obligations stipulated in these Rules&Regulations on time.

8.6 Contestants violating copyrights of the third parties.

Participation is deemed confirmed by submitting photos to the Contest also this deed signifies consent with the Contest Rules&Regulations.

In accordance with Federal Law No. 152-FZ "On Personal Data" a participant grants consent to collection, processing and storage of personal data. The Organizer is authorized to transfer personal data to third parties whom it engages for the Contest, including persons authorized to

send and deliver prizes.

Participants guarantee that they have the copyright to the photographs they have sent in the Contest.

Responsibility for failure to respect the authorship of the submitted photographic works lies with the contestants.

The Organizer reserves the right to amend the Rules & Regulations.
